



# Kingsville Primary School Complaints Policy

## PURPOSE

The purpose of this policy is to:

- provide an outline of the complaints process at Kingsville Primary School so that students, parents and members of the community are informed of how they can raise complaints or concerns about issues arising at our school
- ensure that all complaints and concerns regarding Kingsville Primary School are managed in a timely, effective, fair and respectful manner

## SCOPE

This policy relates to complaints brought by students, parents, carers, or members of our school community and applies to all matters relating to our school.

In some limited instances, we may need to refer a complainant to another policy or area if there are different processes in place to manage the issue including:

- Complaints and concerns relating to fraud and corruption will be managed in accordance with the department's [Fraud and Corruption Policy](#)
- Criminal matters will be referred to Victorian Police
- Legal claims will be referred to the Department's Legal Division
- Complaints and concerns relating to child abuse will be managed in accordance with our Child Safety Responding and Reporting Obligations Policy and Procedures

## POLICY

Kingsville Primary School welcomes feedback, both positive and negative, and is committed to continuous improvement. We value open communication with our families and are committed to understanding complaints and addressing them appropriately. We recognise that the complaints process provides an important opportunity for reflection and learning.

We value and encourage open and positive relationships with our school community. We understand that it is in the best interests of students for there to be a trusting relationship between families and our school.

When addressing a complaint, it is expected that all parties will:

- be considerate of each other's views and respect each other's role

- be focused on resolution of the complaint, with the interests of the student involved at the centre
- act in good faith and cooperation
- behave with respect and courtesy
- respect the privacy and confidentiality of those involved, as appropriate
- operate within and seek reasonable resolutions that comply with any applicable legislation and Department policy
- recognise that schools and the Department may be subject to legal constraints on their ability to act or disclose information in some circumstances

### Complaints and concerns process for students

Kingsville Primary School acknowledges that issues or concerns can cause stress or worry for students and impact their wellbeing and learning. Kingsville Primary School encourages our students to raise issues or concerns as they arise so that we can work together to resolve them.

Students with a concern or complaint can raise them with a trusted adult at school, for example, with their classroom teacher, a member of the specialist teaching team or with a member of school leadership. This person will take your concern or complaint seriously and will explain to you what steps we can take to try to resolve the issue and support you.

You can also ask your parent, carer or another trusted adult outside of the school, to talk to us about the issue instead. Information about our parent/carer complaints and concerns process is outlined further below. The parent/carer process also applies to students who are mature minors, refer to: [Mature Minors and Decision Making](#).

Other ways you can raise a concern or complaint with us include:

- talking to a member of our Junior School Council about your concern and any suggestions you have for resolving it
- student suggestion boxes
- talking to a school student leadership member, such as a School or House captain, about your concerns and suggestions you have for resolving it
- participating in our Attitudes to School Survey (for Grades 4-6)
- participating in informal, classroom based student surveys and other classroom based feedback opportunities

### Complaints and concerns process for parents, carers and community members

Preparation for raising a concern or complaint

Kingsville Primary School encourages parents, carers or members of the community who may wish to submit a complaint to:

- carefully consider the issues you would like to discuss
- remember you may not have all the facts relating to the issues that you want to raise
- acknowledge that a common goal is to achieve an outcome acceptable to all parties
- maintain and respect the privacy and confidentiality of all parties
- show respect and understanding of each other's point of view and value difference, rather than judge and blame
- exercise patience and respect for the subsequent process of assessment and reconciliation undertaken
- be informed by checking the policies and guidelines set by the Department and Kingsville Primary School (see "Further Information and Resources" section below)

### Support person

You are welcome to have a support person to assist you in raising a complaint or concern with our school. Please advise us if you wish to have a support person to assist you, and provide their name, contact details, and their relationship to you.

### Raising a concern

Kingsville Primary School is always happy to discuss with parents/carers and community members any concerns that they may have. Concerns in the first instance should be directed to your child's classroom teacher. Where possible, school staff will work with you to ensure that your concerns are appropriately addressed.

### Making a complaint

Where concerns cannot be resolved in this way, parents or community members may wish to make a formal complaint to the Principal or other member of the school leadership team

If you would like to make a formal complaint, in most cases, depending on the nature of the complaint raised, our school will first seek to understand the issues and will then convene a resolution meeting with the aim of resolving the complaint together.

Where concerns cannot be resolved in this way, parents or community members may wish to make a formal complaint to a member of the School Leadership Team.

If you would like to make a formal complaint, in most cases, depending on the nature of the complaint raised, our school will first seek to understand the issues and will then convene a resolution meeting with the aim of resolving the complaint together. The following process will apply:

- 1. Complaint received:** Please either email, telephone or arrange a meeting through the front office with the Assistant Principal, to outline your complaint so that we can fully understand what the issues are. We can discuss your complaint in a way that is convenient for you, whether in writing, in person or over the phone.
- 2. Information gathering:** Depending on the issues raised in the complaint, the Principal, Assistant Principal or nominee may need to gather further information to properly understand

the situation. This process may also involve speaking to others to obtain details about the situation or the concerns raised.

- 3. Response:** Where possible, a resolution meeting will be arranged with a member of School Leadership to discuss the complaint with the objective of reaching a resolution satisfactory to all parties. If after the resolution meeting we are unable to resolve the complaint together, we will work with you to produce a written summary of the complaint in the event you would like to take further action about it. In some circumstances, the Principal may determine that a resolution meeting would not be appropriate. In this situation, a response to the complaint will be provided in writing.
- 4. Timelines:** Kingsville Primary School will acknowledge receipt of your complaint as soon as possible (usually within two school days) and will seek to resolve complaints in a timely manner. Depending on the complexity of the complaint, Kingsville Primary School may need some time to gather enough information to fully understand the circumstances of your complaint. We will endeavour to complete any necessary information gathering and hold a resolution meeting where appropriate within 10 working days of the complaint being raised. In situations where further time is required, Kingsville Primary School will consult with you and discuss any interim solutions to the dispute that can be put in place.

#### Unreasonable Complainant Conduct

The Principal can determine if a complainant's conduct is unreasonable. Unreasonable complainant conduct is behaviour that:

- is clearly and significantly outside the expectations of confidentiality, cooperation, courtesy and respect
- calls for staff resources and time unjustified by the nature or significance of the complaint
- is vexatious (that is, an action or complaint that is brought without merit, often to cause annoyance to another person)
- is orientated towards conflict

If the Principal determines a complainant conduct is unreasonable they will:

- develop a plan to address the complaint and complainant's interaction with staff
- inform the complainant of the plan
- ensure all staff adhere to the plan as closely as possible

Advice may need to be sought from the Department of Education and Training regional director. If the complainant uses threatening and violent behaviour all Department of Education and Training employees should follow the Occupational Violence Policy.

## Resolution

Where appropriate, Kingsville Primary School may seek to resolve a complaint by:

- an apology or expression of regret
- a change of decision
- a change of policy, procedure or practice
- offering the opportunity for student counselling or other support
- other actions consistent with school values that are intended to support the student, parent and school relationship, engagement, and participation in the school community

In some circumstances, Kingsville Primary School may also ask you to attend a meeting with an independent third party, or participate in a mediation with an accredited mediator to assist in the resolution of the dispute.

## Escalation

If you are not satisfied that your complaint has been resolved by the school, or if your complaint is about the Principal and you do not want to raise it directly with them, then the complaint should be referred to the DET South Western Regional office by contacting:

Kingsville Primary School may also refer a complaint to DET South West Regional Office if we believe that we have done all we can to address the complaint.

## Record keeping and other requirements

To meet Department and legal requirements, our school must keep written records of:

- Serious, substantial or unusual complaints
- Complaints relating to the Child Information Sharing Scheme and Family Violence Information Sharing Scheme, to meet regulatory requirements - refer to Child and Family Violence Information Sharing Schemes for further information

Our school also follows Department policy to ensure that record-keeping, reporting, privacy and employment law obligations are met when responding to complaints or concerns.

- Included in staff induction processes
- Included in transition and enrolment packs
- Discussed at parent information nights/sessions
- Annual reference in school newsletter
- Shared via Compass annually
